<p>MORTON TOWNSHIP ROAD DISTRICT NEWS</p> <p>IT'S HARVEST SEASON</p> <p>Farmers in Morton Township have already started harvesting corn and beans.</p> <p>Please use caution and drive defensively!!</p> <p>Motorists are urged to slow down and approach farm machinery with care NEVER pass implements in the NO PASSING ZONES</p> <p>and maintain a safe following distance.</p> <p>START SEEING FARMERS</p> <p>WATCH FOR FARM MACHINERY</p> 	<p>TOWNSHIP ASSESSOR'S DEPARTMENT</p> <p>SENIOR CITIZENS HOMESTEAD EXEMPTION *Apply the year the homeowner turns 65.</p> <p>*Owner must be 65 or older and living in the home. If the owner goes into a nursing home the exemption will continue as long as the home continues to be occupied by the qualifying person's spouse if the spouse is 65 or older or if the home remains unoccupied but is still owned by the qualifying person.</p> <p>*Exemption is for \$5,000 in assessed valuation. Using the current tax rate, this exemption is worth approximately \$350 - \$360.</p> <p>*Apply at Township Office (300 W. Jefferson) or at the Supervisor of Assessment's office (Room 401, McKenzie Building; 11 S. 4th St.; Pekin, IL 61554.</p> <p>*Will be renewed automatically every year thereafter that the qualifying person lives in that home. If they move they must reapply for the new residence.</p> <p>Disabled Veterans' Standard Homestead Exemption (DVSHE)</p> <p>* Primary residence occupied by a disabled veteran on January 1 of the assessment year</p> <p>Disabled veteran award letter states 30% less than 50% \$2,500 reduction in property's EAV</p> <p>Disabled veteran award letter states 50% less than 70% \$5,000 reduction in property's EAV</p> <p>* Disabled veteran award letter states 70% to 100% veteran pays NO property tax</p> <p>* Must reapply annually at the Township Office or Supervisor of Assessment's Office since disability can change from year to year. Proof of disability must be for the same year as the assessment year.</p> <p>*After initial application, Tazewell County Assessment Office will send out forms annually usually between February 17th to March 1st. These forms must be completed and returned to Tazewell County Assessment Office by July 1. Call 266-6445 or 477-2275 to request a form for first time applicants.</p>
